#### $\bigcirc$ Areas

'Global Leadership' Category : Registration fee and living expenses are covered for selected citizens of developing nations, who are currently enrolled in or have been accepted by a Korean university for a master's (or doctoral) degree program related to the environment, safety or health

#### $\odot$ Method of Selection

A. Eligible applicants shall meet the selection standards, have a sufficient command of language(Korean or English) and their study plan will be comprehensively reviewed.

B. Documents will be screened and an interview conducted by the scholarship committee.

C. Previous studies, activities or awards etc. in the related areas will count as advantages.

1. Environment: Forest environment protection, environmental conversion,

environmental engineering, eco-environmental science, earth environment system engineering, environment management, bio-resource environmental studies, eco-environment systems, construction environment energy engineering, industrial engineering, marine environment engineering, environmental health studies, social environment design engineering, eco-friendly bio-conversion, environmental education, environmental bio-engineering, environmental atmosphere studies, environmental energy engineering, forest environment, marine environment, energy environment system engineering, energy environment engineering, etc.

**2. Safety:** Industrial management safety engineering, safe environment technology convergence studies, energy safety engineering, health & safety convergence studies, safety & environment system engineering, industrial safety studies, climate & environment, environment & ecosphere engineering, etc.

**3. Health:** Environmental health studies, industrial health studies, preventative medicine (environment major or industrial medicine), industrial safety & health studies, health & environment systems, health & environment convergence studies, environment & international health studies, industrial environment & health studies, etc.

#### 5. Please Note:

#### ○ Obligations of Recipients

**A.** Recipients must attend follow-up talent development programs (camps, workshops, etc.).

**B.** Recipients must submit a study activity report each semester and the outcomes of their study when graduating from their programs.

**C.** Recipients will go through interim evaluations (academic attitude, achievements, record etc.), which will determine whether support will be continued.

#### $\odot$ Other Issues

#### A. Whether to support duplicate

\_Receipt of loans for registration fees, scholarships from other foundations or the accepting school, or benefit from the BK21 program, etc. will negate receipt of the Scholarship program.

\_Working scholarships, project participation, and laboratory assignments, etc. are possible.

#### B. Suspension of support

\_Recipients will be disqualified should they quit in the middle of the program for personal reasons.

\_Recipients will be disqualified if they are deemed to have produced poor study outcomes or are insincere about the program during semester and annual evaluations.

#### C. Reasons for Suspension and/or Return of Support

\_If the recipient is found to have received redundant benefits or submitted false

documents.

\_If the recipient withdraws from the academic program.

\_If the recipient damages the good reputation of the Foundation through criminal activity, an accident or violation of school regulations, etc.

\_If any of the above occur, the recipient must repay the Foundation an amount equal to the entire support received.

#### D. Respite & Leaves of Absence

\_A leave of absence is permitted for a maximum of 2 semesters (1 year) for unavoidable circumstances (sickness, family affairs, etc.). Documented evidence must be provided.

\_A period of respite may be granted after completion of the academic program until graduation (3 years for the masters' program and 5 years for the doctorate program).

#### E. Payment Method

\_The Foundation will pay the school directly for the registration fee.

\_Living expenses will be paid monthly into a bank account on the date designated in the pledge.

#### F. Other

\_Recipients must receive an Alien Registration Card after entering Korea. \_If no qualified applicants are identified, then there will be no recipients.

#### G. Follow-up Programs

\_Recipient workshop: Scholarship Certificate Presentation Ceremony and Orientation (to take place in Feb. 2025).

\_Koreashe Foundation Scholar camp(to take place at the end of June 2025).

\_Academic seminar: Safety, health and environment-related seminar (to take place in November 2025).
